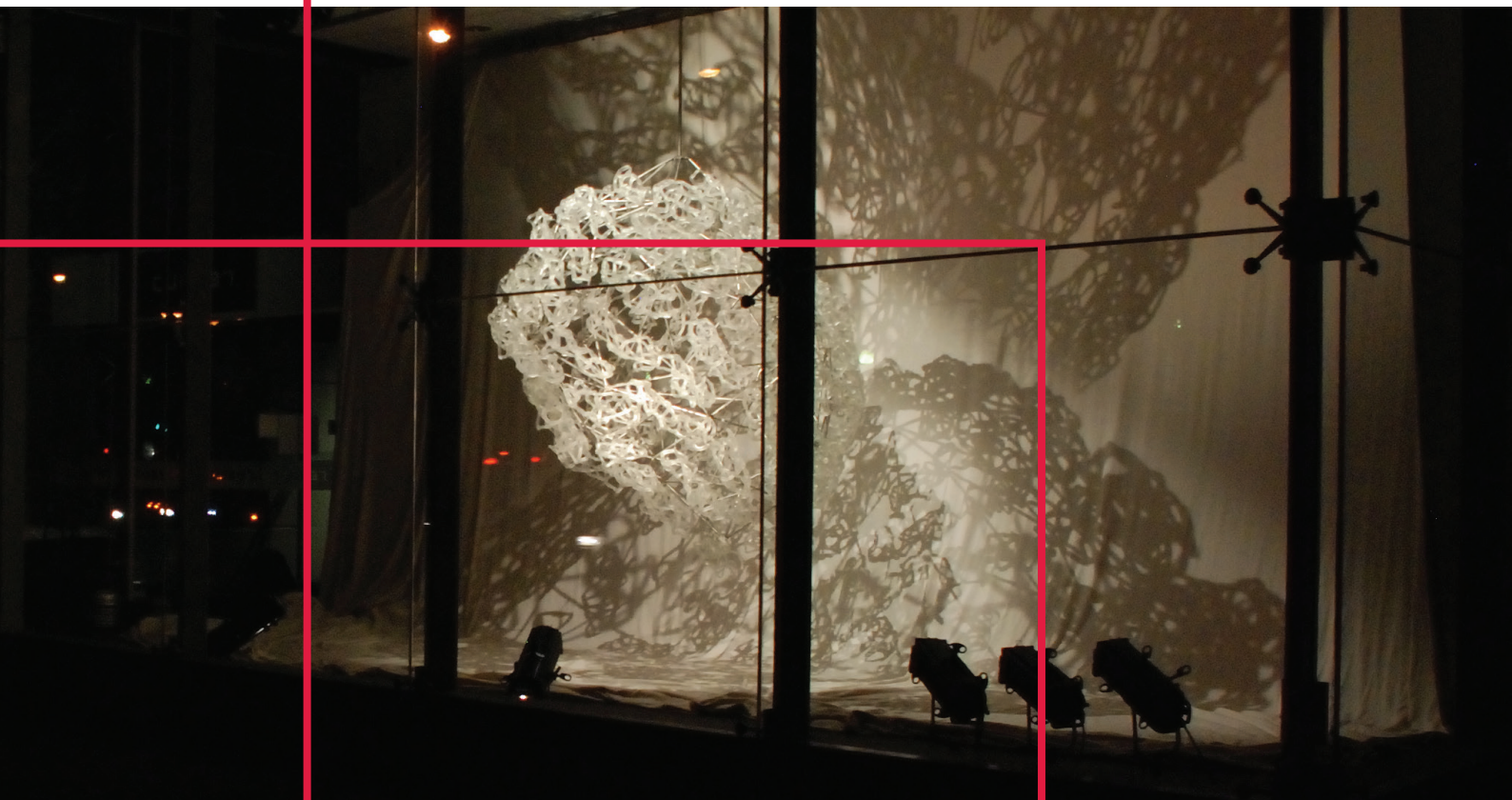

The Frankston Arts Centre (FAC) is a purpose-built performing and visual arts venue.

The Frankston Arts Centre is one of the largest outer metropolitan arts venues in Australia incorporating an 800 seat theatre, 6 exhibition gallery spaces, a function centre, a black box theatre and a creative arts hub.

The Centre attracts approximately 250,000 visitors each year. Over 50% of visitors come from outside the Frankston municipality, most notably from the Mornington Peninsula and Westernport regions, as well as Melbourne's bayside and along EastLink to Ringwood.

Renowned for its variety of theatre, visual arts and digital arts, from local, national and international artists, FAC's mission is to provide and inspire creative experiences that strive for positive community participation and engagement.

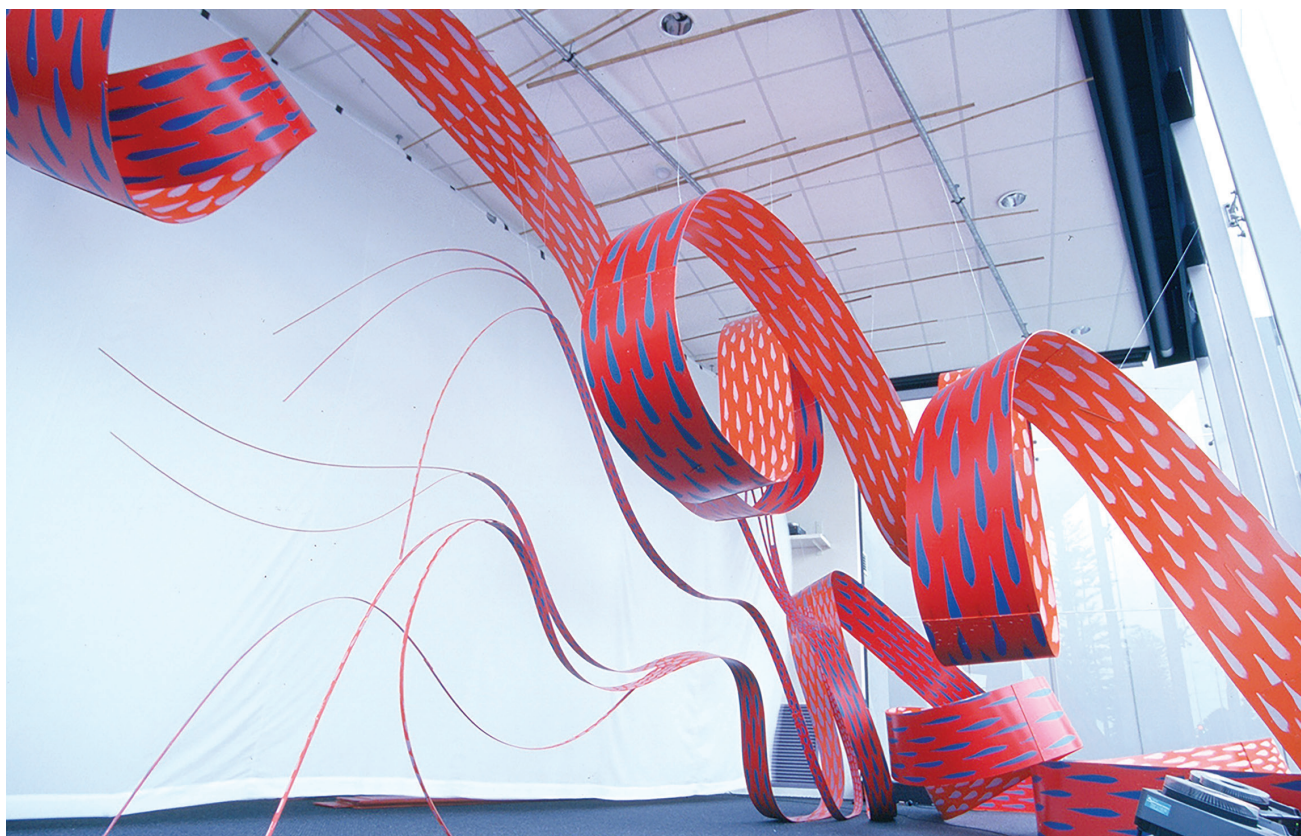

GLASS CUBE GALLERY

Cube 37 derives its name from the Glass Cube at the front of the building. The Glass Cube Gallery defines the image of Cube 37 and aims to showcase artwork that crosses all bounds of imagination.

The Glass Cube can be viewed at all times from the street front, not only by the 250 000 patrons that visit the FAC annually but also by passing foot and automobile traffic.

EXHIBITION OBJECTIVES

The objectives of the Glass Cube Gallery are:

- Develop and portray a striking contemporary identity of Cube 37, Frankston Arts Centre.
- Encourage artists to be creative with their art practice and encourage collaboration across various art forms.
- Produce works that can be interactive and engage a broad cross section of the community via ancillary community engagement activities.

GENERAL GUIDELINES

- Daytime exhibitions generally consist of three dimensional works that are site specific and can also be viewed through the night. Sculpture based installations and sound art applications are strongly encouraged.
- Audience interaction can be encouraged within the space during gallery opening hours. Tuesday-Friday 9am-5pm, Saturday 9am-2pm.
- The installation is of a scale that can be viewed from outside the space from a distance.
- Light based projections, video and cross media art forms and soundscapes are encouraged for Art After Dark.
- Exhibitions are viewed at night time from outside the glass studio including a major audience of passing traffic and guests entering and leaving the performing arts centre.
- Large scale installations are preferred from October to April due to longer daylight hours and digital installations are preferred during the other times of the year. However, if logistical requirements permit, a combination of the two is encouraged. Please speak to the Visual Arts Officer if you are in doubt.
- Collaborations between digital and sculpture artists are suited to the space.
- Please note that height restrictions may apply for artworks within this space.
- The gallery spaces at the Frankston Arts Centre are open to the public and as such all artwork exhibited needs to be suitable for all ages and general public.

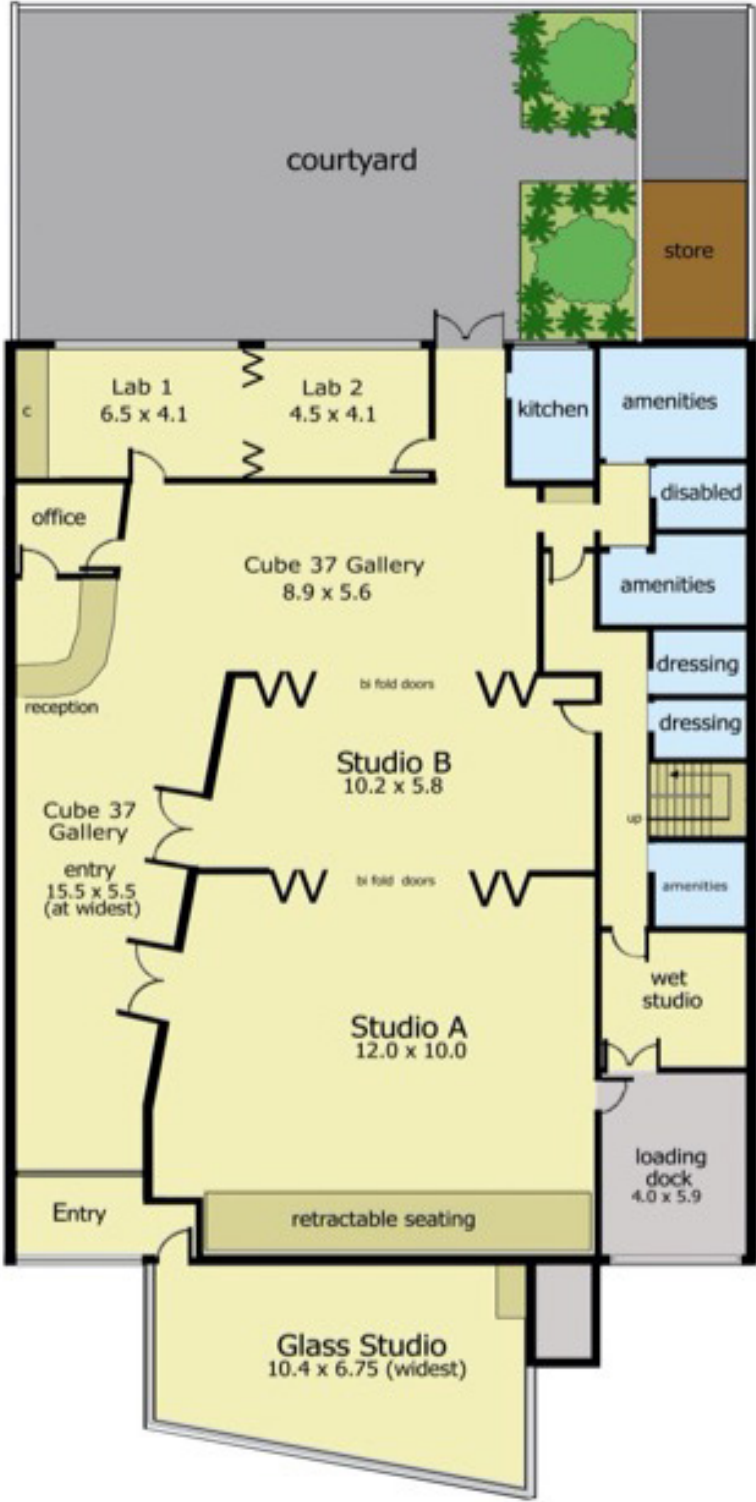
